

IAF 2023 Q4 Quarterly Spotlight

Here are the highlights of IAF work for Q4 2023, which you may want to revisit. Much of the fourth quarter was consumed by a dual focus: new Chief Policy Strategist Elizabeth Denham taking the reins to replace the retiring Marty Abrams, and the concurrent refresh of the IAF Strategy and projects for 2024. October

October 3, 2023 - IAF Chief Policy Strategy Officer **Elizabeth Denham spoke at the Risk Gulf Cooperation Council (GCC) in Dubai**, the first of its kind data protection and AI governance conference. As an international thought leader, she shared her experience of transformation and ignition in the ICO in the UK.

October 12, 2023 – IAF Policy & Strategy call - Regulator Oversight of Machine Learning and Al is Impacted by US State Privacy Laws and Rules on Profiling. A discussion of how U.S. state privacy laws change the way regulators look at machine learning and Al. Why does this matter? Because California, Colorado and the other 9 Attorney Generals will have access on demand to the DPAs conducted to prove that risks have been identified and mitigated when processing includes "risky" profiling. Companies will have to demonstrate that they have conducted the DPAs to identify and mitigate any associated risks. Drafts of California's risk assessment regulations indicate that risk assessments will need to be conducted for "risky" automated decision-making technology. Connecticut, Delaware, Indiana, Montana, Tennessee, Texas, and Virginia all basically have the same definition of profiling as Colorado. Florida's, Oregon's, and California's definitions of profiling are very similar.

IAF leadership team participates in the 45th Annual Global Privacy Assembly (GPA) in Bermuda October 15-19. IAF Chief Policy Strategy Officer Elizabeth Denham spoke on a panel about global efforts to promote consistency and interoperability in data transfers. We celebrated Marty's retirement at a cocktail party at the Hamilton 1609 Restaurant.

November 15, 2023, In London, Chief Policy Strategy Officer **Elizabeth Denham described the details of the UK and CA age-appropriate design codes**, how the differing jurisdictions address free expression, and the implications for children's privacy.

November 17, 2023, Chief Policy Strategy Officer Elizabeth participated in a workshop Oxford Internet Institute covering important reflections about what we have learned from Cambridge-Analytica five years on - are elections safer, how do new technologies impact digital election campaigns and information and 3rd party governance.

November 28, 2023 - Chief Policy Strategy Officer **Elizabeth Denham spoke before the Canadian Parliament House of Commons** hearing on the Bill C-27 (An Act to enact the Consumer Privacy Protection Act, the Personal Information and Data Protection Tribunal Act and the Artificial Intelligence and Data Act and to make consequential and related amendments to other Acts.)
